

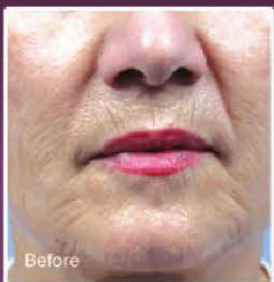
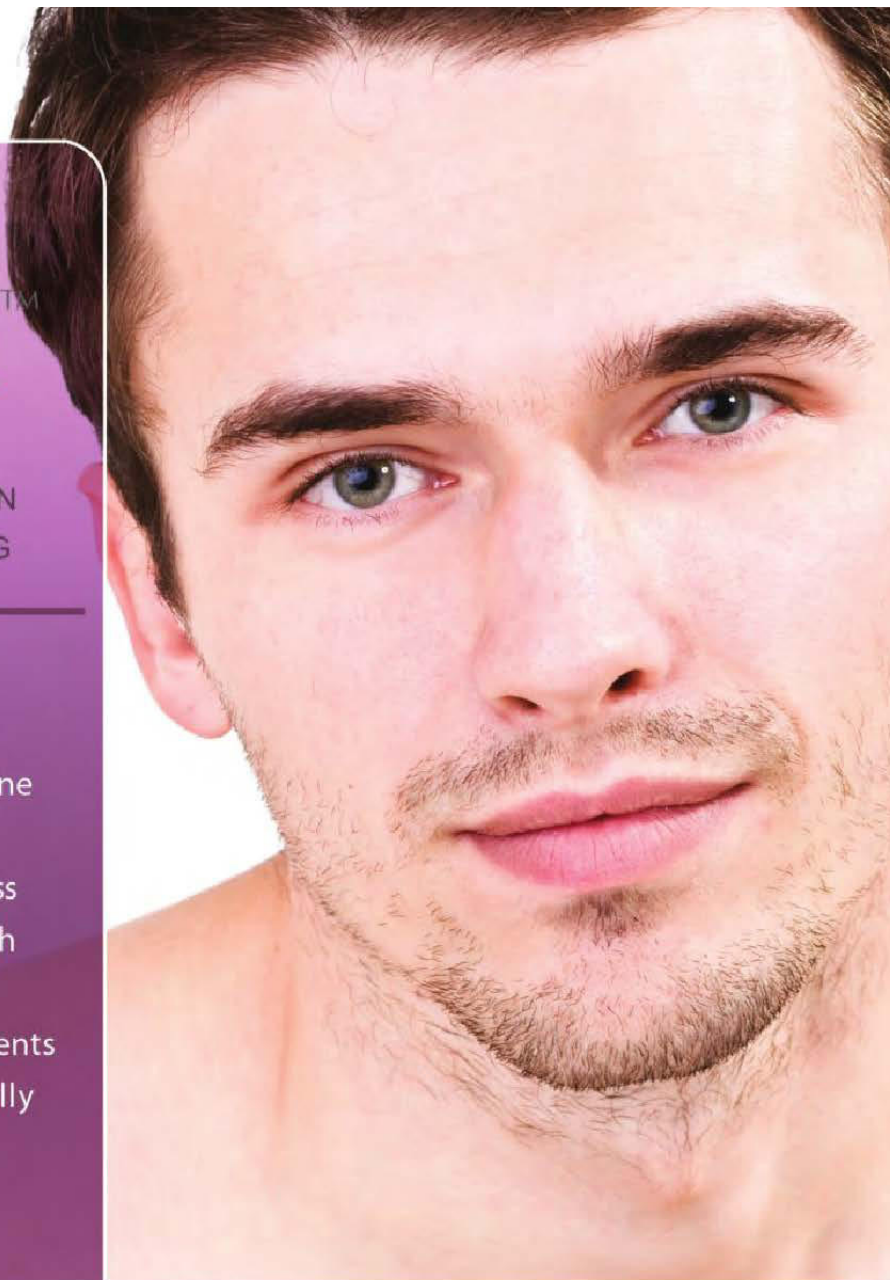

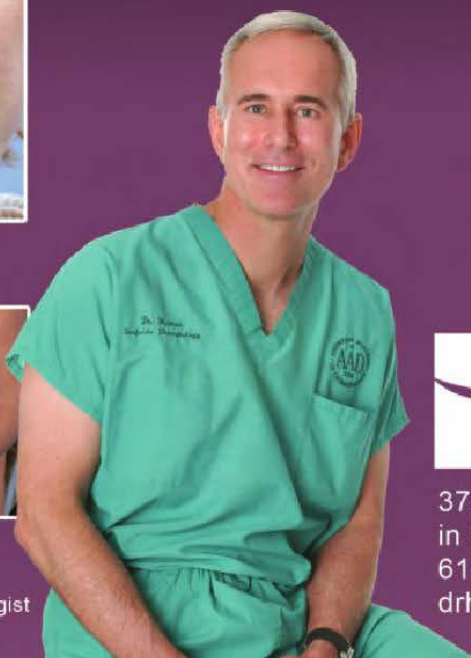

WITH REJUVENATED SKIN TO MATCH A RENEWED YOUTHFUL STAMINA!

the April 2011 *Rage Monthly* article, "My Personal Experience With Anti-Aging Medicine," I shared the experience I had with restoring my energy, mental focus and stamina to a more youthful level. The national feedback received encouraged me to share my experience with three new revolutionary rejuvenation procedures. The first procedure, **CoolSculpting**, was administered to those unwanted love handles and spare tire that generally accompany most who dare to live past our chronological youth. It is a simple process of cooling unwanted fat cells, that the body then naturally and harmlessly flushes out of the body. In 2012, I underwent the painless procedure on my stomach and sides. In a period of four months, my waist line went from 38-40 to 34-36 inches and has remained there since. Rid of those inches, I once again wear my jeans lower and more flatteringly on my hip. The number of treatments and cost will vary from person to person. But compared to surgical liposuction, its accompanying downtime, considerable discomfort and the cost of such an invasive procedure, this was truly a painless bargain. The second and third procedures, the tandem processes of **Fractora** and **Fractora Firm** were experienced over the past three months. For the first, Fractora, a numbing cream was applied one hour before the procedure to minimize any possible discomfort and I sat comfortably reading a book as I waited. The treatment itself took an additional hour.

During the Fractora Firm treatments, I felt just a little flushed as the Radio Frequency (RF) waves were applied to the skin. At the end of each treatment, a

soothing, healing gel was applied to the treated areas. As the numbing gel wore off, the sensation for me was like having a mild sunburn—followed in three days by the skin peeling as you would expect.

Despite my skepticism, the combination of Fractora and Fractora Firm dramatically rejuvenated the texture and tone of my facial and neck skin. The procedures greatly reduced, and in many instances, erased the unsightly age spots, sagging skin, fine lines and deep wrinkles that had made me look much older than I felt. It were as though my skin had been resurfaced. By using controlled RF heat, my collagen was also rejuvenated and replenished, leaving me with firmer, more radiant skin. Best of all, the stimulated collagen should continue to rebuild itself over the coming weeks. (The collagen under the skin gives the skin its elasticity.)

The good news is that there are safer and more realistic options, which allow us to tailor choices with our doctors to achieve results better-aligned with our budgets and goals. Best of all, with little or no discomfort or down time, these procedures can also rejuvenate skin over other areas.

NOTE: As with CoolSculpting, the number, cost and type of Fractora and Fractora Firm treatments elected and the results achieved will vary from person to person. Those considering these steps should do their own research and consult, as I did, with their dermatologist to determine treatment plans. I was very pleasantly surprised with the results.
